1. Conditions for Nomination/Self-Nomination for the Board of Directors (SB) Member

1.1 Individual shareholders holding at least ten percent (10%) of the total voting shares of the Company, whose names appear on the list of shareholders entitled to attend the General Meeting of Shareholders and who meet all criteria and conditions to become SB members as stated in Section 2 below, are entitled to nominate or self-nominate as SB members.

1.2 Shareholders or groups of shareholders holding:

- From 10% to less than 20% of total voting shares: entitled to nominate one (01) candidate;
- From 20% to less than 30%: entitled to nominate up to two (02) candidates;
- From 30% to less than 40%: entitled to nominate up to three (03) candidates;
- From 40% to less than 50%: entitled to nominate up to four (04) candidates;
- From 50% to less than 60%: entitled to nominate up to five (05) candidates;
- From 60% to less than 70%: entitled to nominate up to six (06) candidates;
- From 70% to 80%: entitled to nominate up to seven (07) candidates;
- From 80% to less than 90%: entitled to nominate up to eight (08) candidates;
- From 90% or more: entitled to nominate up to nine (09) candidates.



- 2. Number of Positions, Criteria, and Conditions for SB Membership
- **2.1** Number of Board of Directors members to be elected for the 2021–2026 term: **01 member**
- **2.2** Criteria and conditions for becoming an SB member: Candidates nominated or self-nominated must meet the qualifications and conditions for Board of Directors members as stipulated in the Company Charter and Internal Governance Regulations.
